The following terms and conditions are an integral part of this application for appearance bond No. _____ dated _____

 conditioned upon full compliance of all said terms and conditions and is a part of said bond and application therefor.

- UNITED SURETY UNDERWRITERS, as bail, shall have control and jurisdiction over the Defendant during the term for which the bond is executed and shall have the right to apprehend, arrest and surrender the Defendant to the proper officials at any time as provided by law.
- In the event surrender of Defendant is made prior to the time set for Defendant's appearances, and for reason other than as enumerated below in paragraph 3, then Defendant shall be entitled to a refund of the bond premium.
- It is understood and agreed that the happening of any one of the following events shall constitute a breach of Defendant's obligations to UNITED SURETY UNDERWRITERS hereunder, and UNITED SURETY UNDERWRITERS shall have the right to forthwith apprehend, arrest, and surrender Defendant, and Defendant shall have no right to any refund or premium whatsoever. Said events which shall constitute a breach of Defendant's obligations hereunder are:
 - If Defendant shall depart the jurisdiction of the court without the written consent of the court and UNITED SURETY UNDERWRITERS or its Agent.
 - If Defendant shall move from one address to another without notifying UNITED SURETY UNDERWRITERS or its Agent in writing prior to said move.
 - If Defendant shall commit any act which shall constitute reasonable evidence of Defendant's intention to cause a forfeiture of said bond.
 - If Defendant is arrested and incarcerated for any offense other than a minor traffic violation.
 - If Defendant shall make any material false statement in the application.
